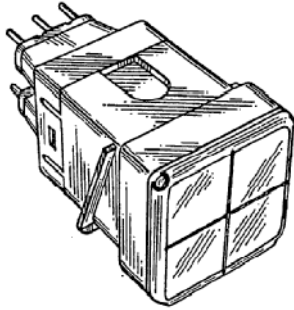

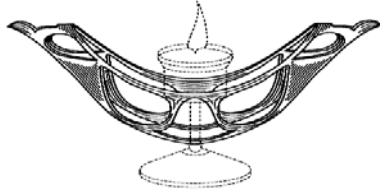
Example of a design for a light source.

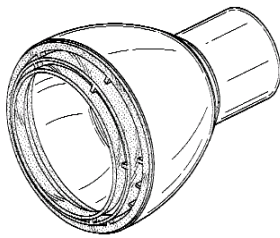

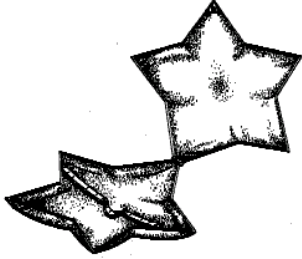

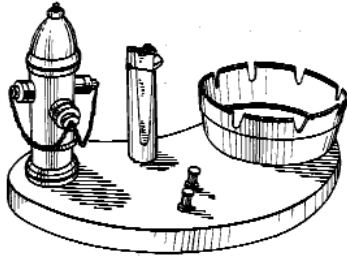

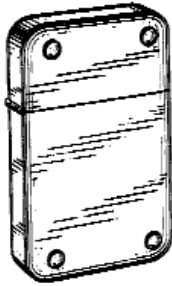

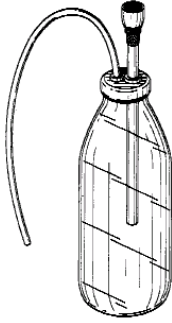

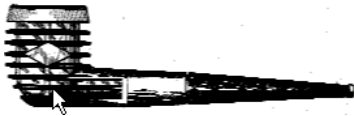

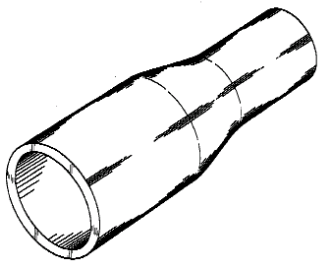

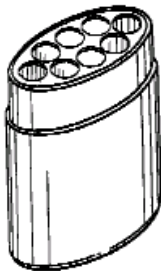

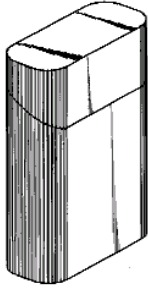

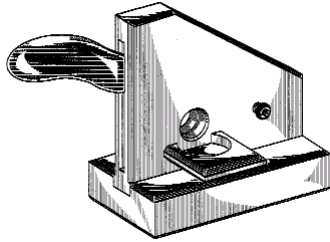

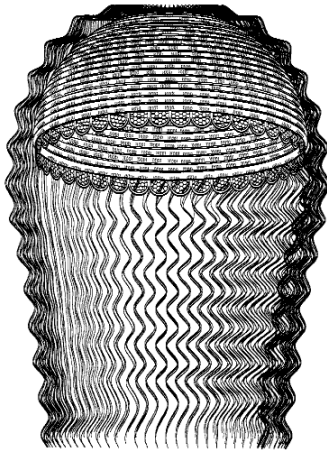

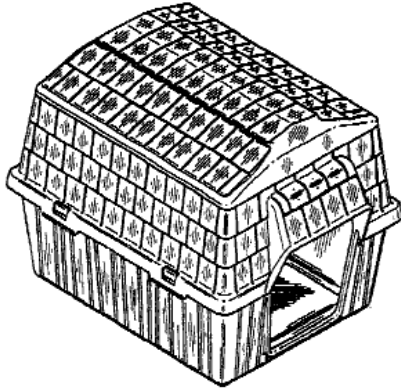

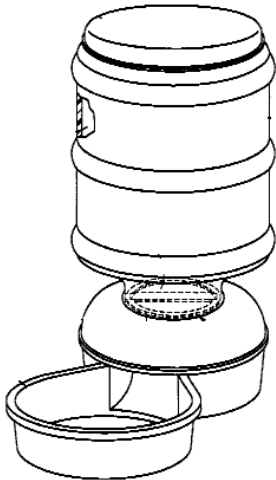

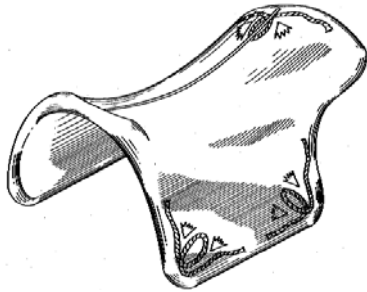

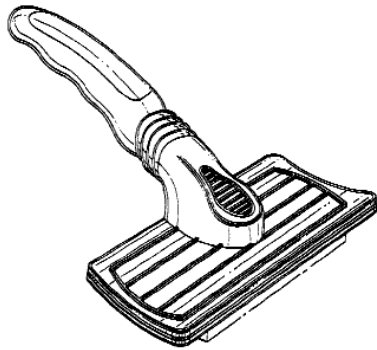
