Filing for Accelerated Examination Of a New Application

The following Doc Codes and Instructions should ONLY be used for filing for Accelerated Examination of a New Application.

Accelerated Examination applications must meet the following conditions:

- Be filed through EFS-Web
 - All Follow-on documents must also be filed through EFS-Web
 - You MUST be a registered user to file follow-on papers through EFS-Web
 - Should use form PTO/SB/28 for filing the petition
 - Must be a non-reissue utility or design application
 - All Fees must be paid at time of electronic filing
 - No preliminary amendments present on the filing date of the application
 - No petition for a non-signing inventor
 - Be complete and correct

To be complete the application must contain:

- Petition for 12-month Accelerated Exam (Form PTO/SB/28)
- Statement of Pre-examination Search
- Examination Support Document
- And the usual application contents -- Required upon filing for Accelerated Examination
 - o Basic filing fee, search fee and examination fee
 - o IDS
 - o Executed oath or declaration
 - o Specification
 - Abstract
 - o Transmittal letter
 - Should include suggested classification, by class and subclass. Class and subclass could also be submitted using the USPTO form fillable ADS
 - If necessary
 - Application size fee
 - Drawings
 - Specification- Not in English
 - Translation of Foreign Priority Documents
 - ADS

Filing Walk-through Example for Accelerated Examination through EFS-Web:

Complete usual steps needed for filing a new application

• Select "Application Part" category, attach all the applicable application documents for your new filing

The following Doc Codes and Instructions should ONLY be used for filing for Accelerated Examination of a New Application:

- Select Petition category, then select "Petition for 12-month Accelerated Exam" from available options

 Attach your filled out PTO/SB/28 form
- Select Petition category, then select "Statement of preexamination search" from available options.
 Attach your statement of preexamination search
- Select Petition category, then select "Examination support document" from available options
 - Attach your Examination support document
- All Fees must be paid at time of electronic filing
 - Select General Transmittal category. If you pay via EFS-Web using the "Calculate Fees" and "Pay Fees" tabs, the correct document will be generated and automatically indexed on submission.
 - Otherwise, select Fee Worksheet (PTO-875)
 - Attach the completed Fee Transmittal(s)

- Select General Transmittal category, then select "Accelerated Exam Transmittal amendment/reply" from available options.

 - Additional documents can be attached, as needed to support your reply, using their regular categories and document descriptions
